



INTRODUCTION

Scholars writing in the sciences and social sciences typically use in-text citations, while humanities scholars utilize endnotes/footnotes. The integrity of scholarship demands that you not take credit for things that are not yours, which is why we cite sources. This overview will help you learn more about APA and how to properly cite.

Step 1 — When to Cite

Direct Quote

“PE (peer education) is defined as people of similar social groupings who are not professional teachers helping each other to learn and learning themselves by teaching”
(Tzu-Chieh et al., 2011).

Paraphrase

The authors claim that as a learner-centered approach, peer education is well-received by students because it provides a great opportunity for them to fully participate in the education program (Outhred & Chester, 2010).

- Someone else's words (e.g., quotations)
- Someone else's ideas (e.g., paraphrases)
- Someone else's illustrations (e.g., images, photographs)
- Someone else's data (e.g., statistics)

Step 2 — APA's 2 Part System-Part I: In-Text Citation

Paraphrase In-Text Citation Example

A participant in the study explained that in the formal classroom, only a few students would speak up and comment during class discussions; however, in the peer study classroom, students who were often silent felt more comfortable engaging in discussions (**Zarifnejad, et al.*, 2018**).

***3 or more authors abbreviate by using et al. --short for the Latin term "et alia," meaning "and others."**

APA's Two-Part System

In-text citation

● In-Text Citation Purpose:

- Include an in-text citation when you refer to, summarize, paraphrase, or quote from another source.
- An in-text citation is the brief form of the reference that you include in the body of your work. It gives enough information to uniquely identify the source in your reference list.

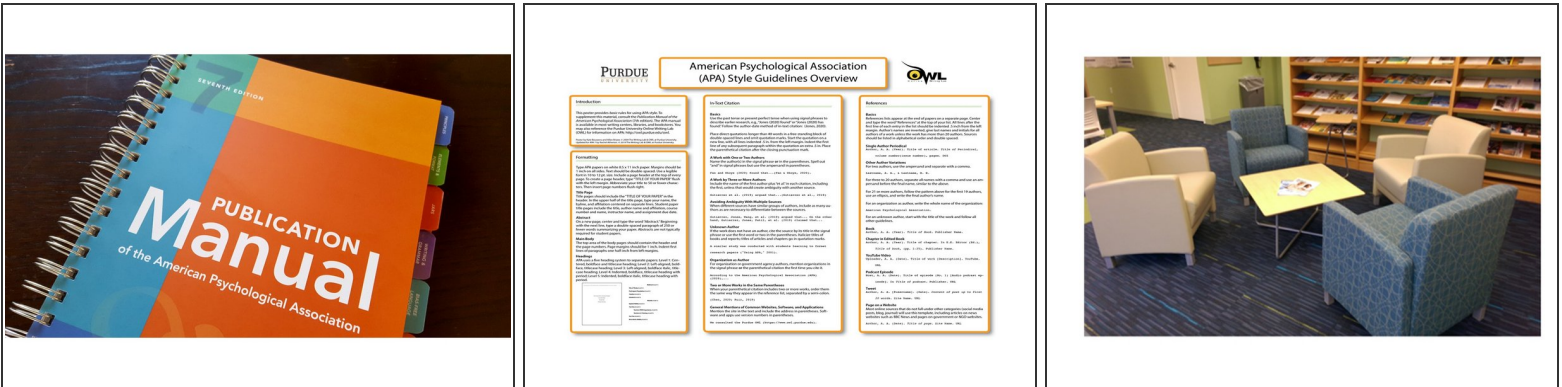
Step 3 — APA's 2 Part System-Part II: Reference(s) Page

- The Reference page is located at the end of your paper. Start a new page and title your list Reference(s)--plural if you have more than one source.
- List in alphabetical order all the sources that you have cited in the paper.
